Note: Information in this addendum takes precedence over original information. All other provisions of the document remain unchanged.

- A. General Clarifications
  - 1. Wherever referenced, the term "Consultant" shall be generally defined to mean the supplier of equipment solicited under this Request for Proposals.
- B. Modifications to Section 1.0 General Information
  - 1. Paragraph 1.1 Timeline. Delete the timeline in its entirety and substitute the following revised timeline:

- C. Modifications to Section 2.0 Evaluation Process and Criteria
  - 1. Paragraph 2.6 Proposal Submission. <u>Delete this paragraph in its entirety and substitute the following:</u>

Proposals may be submitted in either electronic or hard copy format.

Hard copy submission shall consist of three (3) copies of the technical proposal along with one (1) copy of the cost proposal in a **separate sealed** envelope. These four (4) documents shall be submitted in a sealed envelope clearly marked with the proposer's and RFP name. Hard copy proposals shall be delivered to the City of Kenai Public Works Department at 210 Fidalgo Avenue, Kenai, AK 99644.

Electronic submittals shall be emailed to Scott Curtin, Kenai Public Works Director, at <u>scurtin@kenai.city</u>. Electronic submittals shall consist of two separate PDF documents. One PDF of the technical proposal and one password protected PDF of the Cost Proposal. Each document shall be appended to a single email no larger than <u>10 megabytes</u> and containing the password for the cost proposal. The email subject line shall clearly identify the proposer's and RFP name.

- D. Modification to Section 5.0 Evaluation Process and Criteria
  - 1. Paragraph 5.2 Sludge Sampling & Laboratory Analysis. <u>Delete the paragraph in its entirety</u> <u>and substitute the following:</u>
- 5.2 Sludge Sampling & Laboratory Analysis

Each of the proposers may request a sample of the aerobically digested sludge solids currently produced at the Facility (up to 5 gallons). Proposers will then apply simulated treatments at the laboratory scale in order to estimate the performance of their equipment on the sludge at full scale.

To request a sludge sample, proposers shall email Scott Curtin, Kenai Director or Public Works at <u>scurtin@kenai.city</u> by 8:00 A.M. AKDT on May 10, 2021.

#### **RESPONSES TO PROPOSER QUESTIONS**


- Q. Section 1.5 appears to apply to Consulting Services. Please confirm that this section does not apply to this RFP.

- Q. We understand that a sludge sample will be sent from Kenai. Please confirm when the sample will be sent and what information you need from us in order to ship the sample.

We note that sample collection, sample shipping, lab testing and analysis will take 1-2 weeks to complete. Will you be providing an extension to the RFP deadline to provide sufficient time to carry this out?
