CITY OF KENAI Sludge Press Replacement – Phase 1 June 16, 2022

1. Time and Location:

11:00 AM at Kenai WWTF

2. Time and Location of Bid Opening:

- Bids must be received prior to 12:00 PM local time on Tuesday, June 28 at Kenai City Hall, at which time bids will be publically opened and read aloud
- Please carefully review the Bidding and Contract Documents, Specifications, and Drawings
- Questions shall be sent to publicworks@kenai.city by 5:00 PM local time on Monday, June 20

3. **Project Introduction and Overview:**

- Contracting
 - Contractors are required to be licensed by the State
 - Contractors shall comply with Title 36 wage rates
 - The Contract will be awarded to the responsible bidder with the lowest responsive bid
 - Project does not have any "Buy America" provisions
- Existing Conditions
 - The City of Kenai Wastewater Treatment Facility is a conventional activated sludge treatment facility with a rated average day capacity of 1.3 million gallons per day. The original facility, constructed in the 1970s, was an extended aeration system that discharged treated effluent through sand filtration. The WWTF was substantially upgraded in 1982 to the current conventional activated sludge process. Chemical disinfection was added to the treatment process in the mid-1990s. No major work has been completed since the addition of chemical disinfection
 - After removing waste solids from the activated sludge process and reducing their volume in the aerobic digestion process, digested sludge is allowed to settle to the bottom of the digester. It is then conditioned with polymer to facilitate the separation of water and solids and pumped to an existing belt press for sludge dewatering. The sludge dewatering process consists of a belt press and two polymer tanks. Dewatered cake solids from the belt press are hauled to the landfill. A belt conveyor is used to convey cake to dumpsters. The belt press was installed during the upgrades in 1982



- The project scope is defined fully in the Contract Documents. In general:
 - Install one (1) owner furnished Andritz C-5427 screw press
 - Demolition Remove two (2) existing digested sludge pumps, existing polymer system, existing roof-mounted air handler and associated ducting, select lighting, and two (2) existing doors
 - Ancillary Equipment Furnish and install screw press equipment support, access platforms, process piping, two (2) digested sludge pumps, polymer system, washwater booster pump system, and one (1) screw conveyor
 - Ventilation Upgrades Install exhaust fan, makeup air unit, and associated ducting
 - Structural Rehabilitation Install one (1) door and rehabilitate interior rod bracing along two (2) walls
- Owner-Furnished/Contractor-Installed Screw Press
 - Contractor's Responsibilities:
 - Designate delivery date of the screw press in construction schedule, utilizing earliest available delivery dates
 - Review product data and shop drawings, noting discrepancies and other issues in providing for Owner-furnished products in the Work
 - o Receive/unload screw press at Kenai WWTF
 - Jointly inspect Screw Press and appurtenant equipment with Owner
 - Upon completion of the inspection, Contractor assumes possession of the equipment and shall provide suitable storage per the manufacturer's recommendations
 - o Install screw press
 - Schedule/coordinate functional and performance testing and provide lab testing for performance tests
- TecPro is specified as the system integrator. Breakdown of work is discussed in Specification Section 40 90 00
- Project Completion:
 - Substantial Completion: February 28, 2023
 - For work to be substantially complete the screw press shall be operational, fully commissioned, and all operator training complete
 - Final Completion: March 15, 2023
- Liquidated Damages:
 - Substantial Completion: \$500/calendar day
 - Final Completion: \$500/calendar day

The Bidder further declares that the only person or parties interested in the Bid are those named herein, that this Bid is, in all respects, fair and without fraud, that it is made without collusion with any official of the City of Kenai, and that the Bid is made without any connection or collusion with any person submitting another Bid.

The Bidder agrees not to withdraw this bid within forty-five (45) days after the actual date of the bid opening.

TIME OF COMPLETION AND LIQUIDATED DAMAGES

Bidder agrees to commence and complete work as follows:

SLUDGE PRESS REPLACEMENT – PHASE 1

All work, including administrative submittals must be 100% complete on or before March 15, 2023.

TIME OF COMMENCEMENT AND COMPLETION: Work shall commence upon receipt of the Notice to Proceed (NTP). A Notice of Award (NOA) is anticipated on July 7 but may not be issued until as late as August 4, 2022. The contractor has ten days after NOA to provide the required paperwork per the bid documents. The NTP will be issued within 5 business days after receipt of contractor's paperwork. All work must be substantially completed on or before February 28, 2023. Liquidated damages will be charged against the Contractor as provided below.

LIQUIDATED DAMAGES. Liquidated damages will be charged as provided for in the Agreement Documents in the amount of Five Hundred Dollars (\$500.00) for each calendar day.

BID TABULATION AND SUMMARY

Bidder agrees to perform all of the work described and per the conditions in the Bid Documents for the prices stated on this Bid Form.

Prices are to be shown in both words and figures. In case of discrepancy, the amount shown in words will govern. In case of error in the extension of prices, the unit price will govern. Bidder understands that the City reserves the right to reject any or all bids and to waive irregularities in the bidding.

BID GUARANTEE: The Undersigned further agrees that the check or bid bond accompanying the bid is left in escrow with the City, that the amount of the check or bond is the measure of damages which the City will sustain by failure of the Undersigned to deliver said documents within ten (10) days after written notice of the award of contract to him or her, and that check shall become the property of the City, or the bid bond shall remain in full effect, should he or she so fail. But if this bid is not accepted within forty-five (45) days of the date set for the opening thereof, or if accepted and the Undersigned delivers said Agreement, and performance, and labor, and material payment bonds as required, the check shall be returned to him or her and the bid bond shall become void.
