Do you require labor union to all contracts or projects you have?

Response: The City does not provide engineer's estimates or budgets for bidding purposes. Plan holders list is attached to this addenda. This is the first addenda issued for this project. Alaska Department of Labor Title 36 restrictions apply to all government contracts.

01-02 Plan Holder Question

The bid schedule: Last item is described as "Contingent Sum"
The Schedule also has an item described as "Misc. Items"

If the intent is as is, please indicate which items on plans are considered miscellaneous.

Response: "Contingent Sum" is an amount available to and owned by the City to make minor adjustments in the work. "Misc. Items" is a catch all available to the contractor to account for any potential item that may be required to provide a 100% complete project but may not be specifically and separately called out for in the construction documents. The plans do not call out every nut, bolt, fitting, fastener, etc. that may be needed to provide a complete installation.

01-03 Plan Holder Question

Do you have engineer's estimates or general cost range information available for the two bid solicitations that close on June 19th, for the 2020 Kenai City Dock Repairs, and for the Peninsula Avenue Bluff erosion repair?

Response: The City does not provide engineer's estimates or budgets for bidding purposes.
